**CONDITIONS APPLICABLE TO A TRANSPORTER**

The Registrar may impose the following conditions on the holder of a firearm transporter's permit:

- (a) A firearm transporter may only lawfully possess and transport firearms and ammunition, if such firearm transporter has obtained the prior written consent of the holder of a licence, permit or authorisation in respect of the firearms and ammunition to be transported;
- (b)
  - (i) a firearm transporter making use of road transport must provide to the person in charge of every transportation, a typed list of names of personnel employed by the transporter who will be directly involved in the transportation of the consignment of the firearms and ammunition;
  - (ii) the list must contain the full names and identity numbers of the employees concerned; and
  - (iii) the list must be attached to a certified copy of the firearm transporter's permit and this documentation must during the transportation be in possession of the person directly in charge of the transportation;
- (c) a certified copy of the firearm transporter's permit and the list of names contemplated in subregulation (b)(ii), will, as long as it is in the possession of the person exercising direct continuous control as contemplated in regulation 68(1)(c), serve as authority to the personnel of a transporter who are named in the list to receive, transport, store and deliver the specified consignment of firearms or ammunition during the permit period;
- (d) the arrangements for the receipt, carriage and delivery of the firearms and ammunition, the safe and efficient transportation thereof, the mode of transport by which the transportation is to take place including the type and construction of the vehicle to be used, as well as, the containers, minimum personnel to be involved, and minimum communication facilities available to the transporter must, within the sole discretion of the Registrar, be adequate to ensure the safe and secure transport and storage of the firearms and ammunition;
- (e)
  - a firearm transporter who transports firearms or ammunition must during the time of such transport be in possession of -
    - (i) a consignment-note on which the following particulars appear:
      - (aa) address of the transporter;
      - (bb) respect of the firearms and ammunition;
      - (cc) and the quantity, type of action, manufacturer's serial number, model, make and calibre of the firearm quantity, make and calibre of ammunition; and
      - (dd) of its final destination;
    - (ii) the permit authorising the transportation of such firearms and ammunition;
    - (iii) any other document which may under this regulation or any other law be required;
- (f) a firearm transporter must with due regard to the provisions of section 146 of the Act and regulation 102(1) keep the documents referred to in subregulation (i) for a period of five years after the transportation at his or her place of business and produce it, on request to any police official for inspection;
- (g) where a firearm transporter is obliged to store the firearms or ammunition for any period of time after receipt and before delivery, such storage must comply with the requirements for safe custody and storage determined by the Registrar which may not detract from the provisions of regulation 86;
- (h) while a consignment of firearms or ammunition is en route it must at all times be under the direct supervision of the firearm transporter or his or her personnel and the transportation must comply with the requirements for the transportation of firearms and ammunition set in terms of subregulation (d);
- (i) the firearm transporter must obtain from the consignee a written confirmation of the taking of possession of the consignment of firearms and ammunition and the confirmation must contain the following information -

- (i) the name and surname of recipient;
- (ii) the recipient's address;
- (iii) the date and time of delivery;
- (iv) the description of firearms and ammunition received; and
- (v) the signature of the recipient which serves as confirmation of the correctness of the information provided in subparagraphs (i) to (iv).


- (j) a copy of the written confirmation contemplated in subparagraph (i) must be delivered by the firearm transporter to the police official who issued the in-transit permit;
- (k) a firearms transporter's permit is not transferable;
- (l) the firearm transporter must immediately notify the Registrar in writing in the event of non-delivery, loss or theft of any of the firearms or ammunition reflected in the consignment note; and
- (m) in the event of any change to the particulars reflected in the permit, a new application must be lodged in accordance with these regulations.

#### **VOORWAARDES VAN TOEPASSING OP 'N KARWEIER**

Die Registrateur kan die volgende voorwaardes afdwing op die houer van 'n vuurwapenskarweierspermit:

- (a) 'n Vuurwapenskarweier mag net wettiglik vuurwapens en ammunisie besit en vervoer indien sodanige vuurwapenskarweier die skriftelike toestemming het van die houer van 'n lisensie, permit of magtiging ten opsigte van die vuurwapens en ammunisie wat vervoer moet word;
- (b)
  - (i) 'n vuurwapenskarweier wat gebruik maak van padvervoer moet 'n getikte lys van name van personeellede in diens van die vervoerder wat direk betrokke is by die vervoer van die besending vuurwapens en ammunisie verskaf aan die persoon wat verantwoordelik is vir elke vervoerproses;
  - (ii) die lys moet die volle name en identiteitsnummers van die betrokke werknemers bevat; en
  - (iii) die lys moet aangeheg word aan 'n gesertifiseerde afskrif van die vuurwapenskarweierspermit en dié dokumente moet tydens vervoer in besit wees van die persoon wat direk in beheer van die vervoerproses;
- (c) 'n gesertifiseerde afskrif van die vuurwapenskarweierspermit en die lys van name wat beoog word in subregulasie (b) sal solank dit in besit is van die persoon wat direkte voortdurende toesig uitoeft soos beoog in regulasie 68(1)(c) as magtiging vir die vervoerder se personeellede wat genoem word in die lys om die spesifieke besending vuurwapens of ammunisie te ontvang, vervoer, veilig te bewaar en af te lewer terwyl die permit geldig is;
- (d) die reëlings vir die ontvangs, vervoer en levering van die vuurwapens en ammunisie, die veilige en doeltreffende vervoer daarvan, die wyse van vervoer, met inbegrip van die konstruksie van die voertuig wat gebruik gaan word, asook die houers, minimum personeeltal wat betrokke gaan wees en minimum kommunikasiefasiliteite tot beschikking van die vuurwapenskarweier moet, na uitsluitlike goeddunke van die Registrateur, voldoende wees vir die veilige vervoer en bewaring van die vuurwapens en ammunisie;
- (e) 'n vuurwapenskarweier wat vuurwapens of ammunisie vervoer moet ten tye van sodanige vervoer in besit wees van -
  - (i) 'n besendingsnota waarop die volgende besonderhede aangeteken is:
    - (aa) Die volle naam, van, identiteitsnummer of registrasienummer, na gelang van die geval, asook die adres van die vuurwapenskarweier;
    - (bb) die naam en adres van die persoon wat die besending gestuur het en die houer van die lisensie, magtiging wat verband hou met die vuurwapens en ammunisie;
    - (cc) die hoeveelheid, tipe slotaksie, vervaardiger se uitkenningsnommer, model, fabrikaat en kaliber asook hoeveelheid, fabrikaat en kaliber ammunisie; en

- (dd) die fisiese adres waar die vuurwapens en ammunisie afgehaal is en die fisiese adres van die bestemming;
- (ii) die permit wat die vervoer van sodanige vuurwapens en ammunisie toelaat;
- (iii) enige ander dokument wat kragtens die regulasie of enige ander wet vereis mag word;
- (f) 'n vuurwapenkarweier moet die dokumente waarna verwys word in subregulasie (i) met inagneming van die bepaling van artikel 146 van die Wet en regulasie 102(1) by sy of haar besigheidsplek hou vir 'n tydperk van vyf jaar na die vervoer van die vuurwapens en moet dit op versoek van 'n polisiebeampte oorhandig vir inspeksie;
- (g) waar 'n vuurwapenkarweier verplig is om die vuurwapens of ammunisie vir enige tydperk na ontvangs en voor aflewing te berg, moet sodanige berging voldoen aan die vereistes vir die veilige bewaring en berging wat bepaal is deur die Registrateur, wat nie mag afbreuk doen aan die voorwaardes van regulasie 86 nie;
- (h) terwyl 'n besending vuurwapens of ammunisie op pad is, moet dit te alle tye onder direkte toesig van die vervoerder van die vuurwapens of sy of haar personeel wees en moet die vervoer voldoen aan die vereistes van die vervoer van vuurwapens en ammunisie wat uiteengesit is in subregulasie (d);

- (i) die vuurwapenkarweier moet van die persoon wat die besending ontvang skriftelike bevestiging ontvang dat die besending vuurwapens en ammunisie in ontvangs geneem is en die bevestiging moet die volgende inligting insluit -
- (i) die ontvanger se naam en van;
  - (ii) die ontvanger se adres;
  - (iii) die datum en tyd van aflewing;
  - (iv) die beschrywing van vuurwapens en ammunisie ontvang; en
  - (v) in die handtekening van ontvanger wat as bevestiging dien van die korrektheid van die besonderhede vermeld subparagrawe (i) tot (iv);
- (j) 'n afskrif van die skriftelike bevestiging wat beoog word in subparagraaf (i) moet deur die vuurwapenkarweier gelewer word aan die polisiebeampte wat die deurgangspermit uitgereik het;
- (k) 'n vuurwapenkarweier se permit is nie oordraagbaar nie;
- (l) die vuurwapenkarweier moet onmiddellik die Registrateur skriftelik in kennis stel indien enige van die vuurwapens of ammunisie wat in die vragbrief aangedui word nie aangelever is nie, verloor is of gesteel is; en
- (m) in geval van enige verandering aan die besonderhede op die permit, moet 'n nuwe aansoek ingedien word in ooreenstemming met die regulasies.


